Provenzalische Erinnerungen - 11. Serie

Jean-Henri Fabre hat sein vielbändiges Werk unter dem Titel "Souvenirs Entomologiques" veröffentlicht. Der vorliegende Übersetzungsband seiner Erinnerungen erscheint als erster unter dem ansprechenderen Titel "Provenzalische Erinnerungen". Fabre stammt zwar aus dem Languedoc, der westlichen Nachbarprovinz jenseits der Rhone, hat aber den weitaus größten Teil seines Lebens in der Provence gelebt und gearbeitet, insbesondere seine "Souvenirs Entomologiques" dort verfaßt. Nicht nur das rechtfertigt die Änderung des Titels. Sie entspricht auch dem universalen Geist Fabres, dessen Erinnerungen über die Insektenkunde weit hinausgehen und dessen Bedeutung gerade darin besteht, daß er ein großer Wissenschaftler und zugleich ein großer Schriftsteller ist.

Discussions of China's early twentieth-century modernization efforts tend to focus almost exclusively on cities, and the changes, both cultural and industrial, seen there. As a result, the communist peasant revolution appears as a decisive historical break. Kate Merkel-Hess corrects that misconception by demonstrating how crucial the countryside was for reformers in China long before the success of the communist revolution. In *The Rural Modern*, Merkel-Hess shows that Chinese reformers and intellectuals created an idea of modernity that was not simply about what was foreign and new, as in Shanghai and other cities, but instead captured the Chinese people's desire for social and political change rooted in rural traditions and institutions. She traces efforts to remake village education, economics, and politics, analyzing how these efforts contributed to a new, inclusive vision of rural Chinese life. Merkel-Hess argues that as China sought to redefine itself, such rural reform efforts played a major role, and tensions that emerged between rural and urban ways deeply informed social relations, government policies, and subsequent efforts to create a modern nation during the communist period.

The Rural Modern

In January 2011, Felani Khatun was shot dead while attempting to cross the border from India to Bangladesh. Her body remained hung on the fence as a warning to those who illegally crossed an international border. Migration to India from the current geographical and political entity called Bangladesh is more than a century old and had begun long before the nation states were created in South Asia. Often termed as 'foreigners' and 'infiltrators', Bangladeshi migrants such as Felani find their way into India for the promise of a better future. Post 1971, there has been a steady movement of people from Bangladesh into India, both as refugees and for economic need, making this migration a complex area of inquiry. This book focuses on the contemporary issue of undocumented Bangladeshi migration to the three Indian states of Assam, West Bengal, and Delhi, and how the migrants are perceived in light of the ongoing discourses on the various nationalisms in India. Each state has a unique history and has taken different measures to respond to Bangladeshi migrants present in the state. Based on extensive fieldwork and insightful interviews with influential members from key political parties, civil society organizations, and Hindu and ethnic nationalist bodies in these states, the book explores the place and role of Bangladeshi migrants in relation to the inherent tension of Indian nationalism.

Refugees have rarely been studied by economists. Despite some pioneering research on the economic lives of refugees, there remains a lack of theory and empirical data through which to understand, and build upon, refugees' own engagement with markets. Yet, understanding these economic systems may hold the key to rethinking our entire approach to refugee assistance. If we can improve our knowledge of the resource allocation systems that shape refugees' lives and opportunities, then we may be able to understand the mechanisms through which these market-based systems can be made to work better and turn humanitarian challenges into sustainable opportunities. This book adopts an inter-disciplinary approach, based on original qualitative and quantitative data on the economic life of refugees, in order to begin to build theory on the economic lives of refugees. It focuses on the case of Uganda because it represents a relatively positive case. Unlike other governments in the region, it has taken the positive step to allow refugees the right to work and a significant degree of freedom of movement through its so-called 'Self-Reliance Strategy'. This allows a unique opportunity to explore what is possible when refugees have basic economic freedoms. The book shows that refugees have complex and varied economic lives, often being highly entrepreneurial and connected to the global economy. The implications are simple but profound: far from being an inevitable burden, refugees have the capacity to help themselves and contribute to their host societies - if we let them.

Human beings have wondered about the stars since the dawn of the species. Does life exist out there – intelligent life, even – or are we alone? The second section (Communication) examines the linguistic and semiotic requirements for interstellar communication. What is needed for successful communication? Are there universal rules for success? What are the possible features – and limitations – of exolanguages? What is required for recognizing a message as a message? The third section (Culture) considers cultural and societal issues. It explores astrobiology's organization as a scientific discipline, its responsibilities to the public sphere, and its theological implications. It reviews the historically important panspermia hypothesis, along with the popularization of astrobiology and its ongoing institutionalisation. Through addressing these questions, we take our first steps in exploring the immense terra incognita of extraterrestrial life and the human mind.

A new global history of the Soviet invasion of Afghanistan - an invasion whose consequences are still felt in Afghanistan and across the wider world. On 24 December 1979, Soviet armed forces entered Afghanistan, beginning an occupation that would last almost a decade and creating a political crisis that shook the world. To many observers, the Soviet invasion showed the lengths to which one of the world's superpowers would go to vie for supremacy in the global Cold War. The Soviet war, and parallel covert American aid to Afghan resistance fighters, would come to be a defining event of international politics in the final years of the Cold War, lingering far beyond the Soviet Union's own demise. Yet Cold War competition is only a small part of the story. Soviet troops entered a country already at war with itself. A century of debates within Afghanistan over the nature of modern nationhood culminated in a 1978 coup in which self-described Afghan communists pledged to fundamentally reshape Afghanistan. Instead what broke out was a civil war in which Afghans asserted competing models of Afghan statehood. Afghan socialists and Islamists came to the fore of this conflict in the 1980s, thanks in part to Soviet and American involvement, but they represented a broader movement for local articulations of social and political modernity that did not derive from foreign models. Afghans, in conversation with foreigners, set many of the parameters of the conflict. This sweeping history moves between centres of state in Kabul, Moscow, Islamabad, and Washington, the halls of global governance in Geneva and New York, resistance hubs in Peshawar and Panjshir, and refugee camps scattered across Pakistan's borderlands to tell a story that is much more expansive than the Soviet invasion of Afghanistan - a global history of a moment of crisis not just for Afghanistan or the Cold War but international relations and the postcolonial state.

Later, as Cleveland CORE members rose to national prominence in the organization, they advocated an open embrace of black power and encouraged national CORE to develop a notion of black community uplift that emphasized economic populism over political engagement. Not surprisingly, these new empowerment strategies found acceptance in Cleveland. By providing an understanding of the tensions between black power and the mainstream civil rights movement as they manifested themselves as both local and national forces, *Harambee City* sheds new light on how CORE became one of the most dynamic civil rights organizations in the black power era.
